- Install synthetic felt to cover the remaining roof substrate.
- Secure new aluminum drip edge on all perimeters.
- Install new CertainTeed Limited Lifetime Dimensional Shingle roof system complete with all starters, proper venting, valleys, and ridge capping.
- Use a minimum of 5-nails per full shingle for proper securement.
- New step flashing and counter flashing installed around chimneys and other relevant details.
- Install all new projection flashings properly flashed to manufacturer specifications.
- Clean and inspect gutter system when the roof is complete.
- Super Magnets used in and around landscape, drives, and walkways to complete the project.
